



Privacy Policy Shop for Batteries

At Shop for Batteries, accessible from <https://shopforbatteries.nl/>, one of our main priorities is the privacy of our visitors. We want to give you as clear and transparent information as possible about how we use your personal data, so you can feel confident when using our services.

This policy applies to all our uses of personal data, e.g. collection, use, sharing, storing, etc. If you have additional questions or require more information about our Privacy Policy, do not hesitate to contact us.

This Privacy Policy applies only to our online activities and is valid for visitors to our website with regards to the information that they shared and/or collect in Shop for Batteries. This policy is not applicable to any information collected offline or via channels other than this website.

By using our website, you hereby consent to our Privacy Policy and agree to its terms.

1. Information we collect

We collect information as necessary to enable us to identify you and respond to your requests for our products, to provide and improve them, and to send you information and support from time to time.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information that will help us understand more about your needs or help us process your requests for information.

2. How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website
- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features, and functionalities
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud

3. Log Files

Shop for Batteries follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

4. Cookies

Like any other website, Shop for Batteries uses 'cookies'. Cookies are small bits of text that are downloaded to the devices you use to reach and use a website. Your browser or device holds these cookies and makes them available every time you visit that site again so that it can recognize you and remember important information about you.

Can I change my cookie preferences?

You can always change your cookie preferences or delete existing cookies from the controls at the bottom of every page on this website. Browser settings also allow you to choose whether or not to accept cookies or limit certain cookies.

How do we use cookies?

The types of information typically collected by cookies include information relating to your use of our website, your device's IP address and browser type and how you arrived on this website. We primarily use cookies to provide user authentication for features like the help desk, product registration and RMA services but we also make use of visitor statistics to improve your user experience.

5. Transfer of personal data to third countries

Where our business partners, suppliers or group affiliates are operating from a country outside the European Union (EU) or the European Economic Area (EEA), we may be required to transfer personal data to such a third country. Whenever we transfer your Personal Data to a third country having a lower level of protection of personal data compared to the EU/EEA, we use the standard contractual clauses approved by the European Commission to ensure a sufficient level of protection for your personal data.

6. How long we keep your personal data

We don't want to have personal data just lying around, so we only keep your personal data for as long as it's needed. That need is typically linked to our obligation to deliver our products to you. If you have signed up for any of our offers the personal data necessary for that product will be retained for the duration of your customer relationship with us.

7. Rights

- Right to information and access

You have the right to get information about the use of your personal data. You can also ask for a copy of your personal data.

- Right to erasure

Under certain circumstances, you have a right to request that we delete your personal data. This is the case for example if the personal data is no longer required for the purposes it was collected for or the personal data has been unlawfully processed.

- Right to rectification

You have the right to update or correct any inaccurate personal data about you that we have and to ask us to have incomplete personal data completed.

- Right to restriction

You have the right to ask for a restriction of your personal data. That is the case for example when the accuracy of the personal data is contested by you, or the processing is unlawful, but you do not want us to delete it and instead you request that we restrict our use of it.

- Right to withdraw your consent

You have the right to withdraw any given consents to our use of your personal data.
